What does the Bible Say About Giving?

The Widow's Offering

There are at least three important things about

giving in this story of the widow's offering:

God values our offerings differently than man does.

In God's eyes, the value of the offering is not determined by the amount of the offering. The text says that the wealthy gave large amounts, but the widow's offering was of much higher value because she gave all that she had. It was a costly sacrifice. Note that Jesus did not say she put in more than *any* of the others; he said she put in more than *all* the others.

Our attitude in giving is important to God.

The text says Jesus "watched the crowd putting their money into the temple treasury." Jesus observed the people as they gave their offerings, and he watches today as we give. If we give to be seen by men or with a stingy heart toward God, our offering loses its value. Jesus is more interested and impressed by *how* we give than *what* we give. We see this same principle in the story of Cain and Abel. God evaluated Cain and Abel's offerings. Abel's offering was pleasing in God's eyes, but he rejected Cain's. Rather than giving to God out of thankfulness and worship, Cain may have presented his offering with evil or selfish intent. Maybe he had hoped to receive special recognition. Regardless, Cain knew the



right thing to do, but he didn't do it. God even gave Cain an opportunity to make things right, but he chose not to.

This illustrates again that

God watches **what** and **how** we give. God not only cares about the quality of our gifts to him, but also the attitude in our hearts as we offer them.

God doesn't want us to be overly concerned with how our offering is spent.

At the time Jesus observed this widow's offering, the temple treasury was managed by the corrupt religious leaders of that day. But Jesus did not mention anywhere in this story that the widow should not have given to the temple.

Although we should do what we can to ensure that the ministries we give to are good stewards of God's money, we can't always know for certain that the money we give will be spent correctly. We should not be overly burdened with this concern, nor should we use this as an excuse not to give.

It's important for us to find a good church that is wisely managing its financial resources for God's glory and for the growth of God's kingdom. But once we give to God, we don't need to worry about what happens to the money. This is God's problem to resolve. If a church leader or a ministry misuses its funds, God knows how to deal with them.

Finance Council Meeting Minutes—October 2, 2024

Annual Corporate Meeting Summary

Each Parish in the Diocese is a separate Not-for-Profit Corporation. As such it is required to summarize various organizational details and financial results from the previous and current Fiscal Years.

One of those requirements is to issue to parishioners a public summary of Financial Results for the previous Fiscal Year, i.e, 7/1/2023 – 6/30/2024.

The results for our parish will be published in our Bulletin on November 10, 2024.

Regular Finance Council Meeting: Attendees:

Review Financial Report to Parishioners for Fiscal Year 2023 - 2024 – done and unanimously approved during the Corporate Meeting; these results will be published in an upcoming Parish Bulletin. Statements distributed at the meeting:

- One-page Pie Chart summary of results (Revenue and Expenses) with narrative.
- One-page high-level Balance Sheet.
- Joe will also work with Gary Kern to publish this 3 page summary on Parish Website.

Review Year-end Communis Accounts

Chris Frontale pointed out that the Communis fund returned 12% for the Fiscal Year ended 6/30/24. St John's does have access to some of the money if needed.

Review Financial Statements for previous full Fiscal Year (23-24) and current Fiscal Year (7/1/24 – 9/30/24)

- Previous Fiscal Year reviewed and approved during Annual Corporate Meeting.
- Balance Sheet continues to be healthy.
- Income/Expense Statement discussed details around line items which showed significant increase or decrease.

Chris Frontale prepared a 2-page summary of key line items but also distributed a 6-page line item report; good discussion on key items of expense. The council appreciated the thoroughness of the presentation.

Review of Current Year - Collections and Attendance:

- Our budget of \$494,000 (Regular Sunday + online) is higher than last year's \$486,000.
- Total collections vs budget is negative for 1st 13 weeks and worse than last year at this time. These numbers are published in our Weekly Bulletin.
- Chris distributed a chart of 13 Weekly collections vs budget – 5 met or above; 8 below.
- July and Aug showed a surplus but lower than July and Aug for last year, but Sept showed major increase in deficit vs a surplus from last year.
- This will be watched carefully.
- Avg attendance is holding at about 404 per weekend, a bit down from last year.
- Mass streaming usually has about 15 20 viewers.

Catholic Ministries Appeal Update:

St. John's goal for 2024-2025 Campaign is \$78,000, down \$3,000 from last year's goal of \$81,000.

Chris also shared details on how the goal was set for our Parish.

Buildings and Grounds Update:

- Replace HVAC Unit (A/C + Heat) outside West wall of Parish Center. Monroe Piping installed a temporary fix in Dec. of 2023 and estimated that we'd get another year out of the unit.
- Council decided to ask vendors for detailed proposals with timing.
- Repair to Narthex floor floor is becoming very worn in some areas; temporary fix (mats?) is available but tabled the discussion to next meeting.
- Re-facing concrete in front of Church did not discuss current proposal
- Silo and Skylight did not discuss current proposal.
- In light of the number of projects being discussed the Council agreed we needed to update the total list of Capital Projects for SJ and assign priorities for future work. Joe will publish the most recent list before next Finance Council meeting.
- Current Snow Removal/Salting contract with Trimline runs through Spring of 2025. We discussed the need to seek additional bids (Magar?) in summer of 2025.

Finance Council + Parish Council will meet at St. Charles to discuss status and next steps from Pastoral Planning Task Force. The meeting will be held on Tuesday, Oct 15.

Next Meeting - did not set a date.

Non-Operating Expenditures are costs for the parish that are not routine for the parish. This is usually major capital improvements that are being completed, such as HVAC improvements, roof replacements, etc. The prior year number also includes the estimated channeling injunction contribution to the Diocesan Bankruptcy settlement.




